JOHN LUCAS was a member of the same church, [McConnel's Run] and was also advanced in life when he was set apart to the ministry, about 1830. His gifts were very meagre [sic], but he was much loved by his brethren, for his deep toned piety and earnest devotion to the cause of Christ. He was ever ready to do what he could in the Lord's vineyard. He died, at an advanced age, in March, 1848.

Lucas becomes of the age of twenty one so as to place them all on an equallity (sic) having advanced the following sums to some of them To Polly ninety nine dollars To Charity seventy nine dollars To Singleton two hundred dollars To Susannah fifty dollars To John twenty dollars To Thomas thirty dollars To Eliza thirty dollars To William thirty dollars and whereas my daughter Elizabeth is dead it is my will that her husband Joseph Birt shal (sic) not have any more of my property but that my son Singleton take charge of the ballance coming toher for the benefit of her children to be given to them at any time that he may think propper (sic) between now and the time they become of age. It is further my will that the tract of land whereon I now live containing seventy acres and the black girl Mary and her two children Mariah Jane and Isaac togeather (sic) with the further increase, all the household and kitchen furniture and farming utensials (sic) choice of two horses two cows twelve sheep and as many hogs as may do the family shall remain in the possession of my wife Caroline during her natural life or widowhood but if marries, it is my will (at her request) that she shall have one third of the land and property willed her and the other two thirds to be put into the hands of her brother Willis Peak and Singleton P. Lucas for the benefit of my children by her. It is my further wish that all of my just debts be paid out of the property left on the place I now live on and at my wifes death all the land and property left in her possession to be equally divided between my children that I have by her. In testimony whereof I do hereunto set my hand and seal this twenty fifth day of May one thousand eight hundred & forty two.

I have also advanced to my son James ten acres of land his part in full and I have advanced to my daughter Susannah ten acres of land her part in full whereon she now lives and have obligated myself to make a deed to Robert Raines her husband and I have also advanced to my son William ten acres of land his part in full and for which I have obligated myself to make him a deed and that it is my will that these my children to which I have made these advances thus named in this codicil shal (sic) not have any more of my property. It is my will that Willis Peak shall be released from having any thing to do with my estate and that my wife Caroline shall not be bound to give any security as long as she complyes (sic) with my will. 5th It is my wish that my brothers Eliza Lucas and Stephen Lucas have my Osburne farm.

6th It is further my wish that my brother William Lucas have five hundred dollars in money as soon as collected.

7th It is my wish that my sister Nancy Perry have my gold watch.

8th It is my wish that a good substantial stone wall thirty feet square and five feet high be built around the grave yard and a tombstone over my grave.

It is further my wish that if there should not be a sufficiency of money collected that Eliza and Stephen shall pay th amount that is lacking And I do hereby appoint my Uncle Samuel Moore and my brother Eliza Lucas Executors to carry this my last will and testament into effect.
