

Notice of Gravel Road Petition

NOTICE is hereby given that a petition signed by more than 50 freeholders and voters of Jackson Township, will be presented to the Board of Commissioners of Hamilton County, Indiana, at the regular July session, 1907, of said Board, asking for the improvement of a certain highway in said township, which petition is in the following words and figures, to-wit:

State of Indiana, Hamilton County, ss:
To the Honorable Board of Commissioners of Hamilton County, Indiana:

In pursuance to an act of the General Assembly of the State of Indiana, 1905 and all amendments thereto concerning township construction of free gravel roads by taxation, and all other laws in relation thereto, we the undersigned freeholders and voters of Jackson Township, Hamilton County, Indiana, being fifty or more in number, pray that a highway that is already established and of public utility, commencing at the section line dividing sections 8 and 9 and at the lines dividing the lands of E. O. Stanley and Sarah Barron in the north-west quarter of section 9, township 19, north range 4 east, run thence east along the highway to the center line of the east or east half of section 9 township 19 north range 4 east, thence south near three-fourths of a mile to the line dividing Noblesville and Jackson townships, all of said proposed improvement being in Jackson township, and being less than 3 miles in length; that the same be improved by grading, draining, graveling, suitable bridges and culverts, the road bed to be 32 feet wide, grade to be not less than 22 feet between shoulders with good side ditches and with 6 cubic yards of good gravel to the lineal rod.

The said proposed improvement connects with an improved county free gravel road at west end, and at the south end with the township line between Noblesville and Jackson townships and that the same is passed over by Rural Mail Route No. 1 for the delivery of the U.
