meeting which this months meeting having settled this now
falls into the monthly meeting treasury
And the meeting concludes til next in course

At Springfield Monthly meeting the 20th of the 5th Mo 1820
The friends appointed to visit Mathew Tickcock reports they
attended to not much satisfaction therefore this meeting disones
him from being a member of our Society Solomon Wendall
is appointed to inform him the proceedings of this meeting
against him and that he may have a copy of this minute
by applying to the clerk

The friends appointed to prepare a certificate for
George Springer produced one which was approved & signed

The quarterly meeting directs this monthly meeting to raise
the sum of \$825 for the use of the quarter proportioned
as follows Springfield \$16. 44 2/3 Pine woods and Kennet
\$4. 33 1/3 cents each

The preparative meeting complains of Seth Richards for
attending a marriage contrary to discipline taking too
much strong drink using unbecoming language and fitting
Jesse Hodson and Phoenix Albertson are appointed to
visit him and reports to next meeting

Also complains of Micajah Haysworth for fighting
Charles Pidgeon and William Hoggatt are appointed to
visit him on the ocation and reports to next meeting

Enoch Warlen requests a certificate to Senter monthly
meeting in order to accomplish his marriage with a mem-
ber of that meeting Solomon Wendall and Joshua More
are appointed to make the needfull inquire and nothing
appears to hinder prepare one for him and produce to
next meeting

Pine woods preparative meeting recom-
ends and this meeting appoints Benjamin Wendall
overseer in the room of Joseph Hiatt who requested
to be released from that service

And the meeting concludes til next in course

At Springfield monthly meeting the 7th of 6th
month 1820 The friends appointed to visit Seth
Richs reports they have attended to the appointment
to but little satisfaction and that he had no wish
to remane a member of Society therefore this meeting
disones him from being a member of our Society Nat-
han Hoggatt is appointed to inform him the proceedings
of this meeting against him and that he may have
a copy of this minute by applying to the clerk

One of the friends appointed to visit Micajah
Hayworth reported he attended there and they are
continued and to report to next meeting

The friends appointed produced a certificate for
Enoch Harlow which was approved and signed

The preparative meeting informs that Robert
Tomlinson requests to come under the care of
friends John Carter and Ezekeil Turner are appi
anted to visit him and report to a future meeting

And the meeting concludes til next in course
