DEED Jesse M. Foulke to David Hall

Know all men by these presents that we Jesse M. Foulke and Mary Foulke wife of said Jesse M. Foulke of the county of Harrison and state of Ohio in consideration of the sum of four thousand Dollars in hand paid by David Hall of the County of Jefferson and State aforesaid have bargained and Sold and do hereby grant bargain sell and convey unto said David Hall his heirs and assigns forever the following premises situate in the County of Harrison and State of Ohio lying and being in section number eleven (11) of Town ship numbered eight (8) in Range Numbered four (4) in the Steubenville District and bounded and de scribed as follows (to Wit) Beginning at a stone on the section line where a white oak twenty inches diameter bears 45° West four links thence west thirty four chains and eighty links to a stake on Hutchisons line thence with said line north twelve degrees East twenty eight chains to a stake on the road leading from Cadiz to Harrisville thence with said road south fifty seven and a half degrees east fifteen (four pole chains) and sixty links to a stone thence south seventy seven and a half degrees east sixteen chains to a stake thence south fif teen chains and fifty nine links to the place of beginning containing sixty six acres and seven square perches be the same more or less. To have and to hold Said premises with the appurtenances unto the said David Hall his heirs and assigns forever. And the said Jesse M. Foulke for himself and his heirs doth hereby covenant with said David Hall his heirs and assigns that he is lawfully seized of the premises of the premises aforesaid that the premises are free and clear from all encumbrances whatever and that he will forever warrant and de fend the same with the appurtenances unto the said David Hall his heirs and assigns against the lawful claims of all persons whomsoever.
