

DECLARATION FOR PENSION

ACT OF MAY 1, 1920

The Pension Certificate should not be forwarded with the Application

STATE OF Ohio, COUNTY OF Miami, ss:

On this 21st day of July, A. D. 1923, personally appeared before me, a notary public, within and for the county and State aforesaid, Joshua F. Piles who, being duly sworn according to law, declares that he is 81 years of age, and a resident of Pymont county of Montgomery, State of Ohio; and that he is the identical person who was ENROLLED at Dayton Ohio, under the name of Joshua F. Piles on the 5th day of January, 1865, as a private in Co. G 8th Regiment O. V. Cavalry

in the service of the United States, in the Civil War, and was HONORABLY DISCHARGED at Clarkstown N. Va, on the 30 day of July, 1865. That he also served Co. H 44th O. V. I.
